41. **UNFULFILLED CONTINGENCY:** If the Sale and Closing of Buyer's Property is not completed by date specified, this Contract  
42. shall be deemed cancelled due to an unfulfilled contingency. In such event, Buyer shall deliver a notice that the Sale and  
43. Closing of Buyer's Property is not completed no later than the date specified. In the event of Buyer's breach arising from  
44. Buyer's failure to deliver the required notice, Seller shall exercise the option in Section 7b of the Contract to accept the Earnest  
45. Money as Seller's sole right to damages.
