## **MEDIATION OF A BUSINESS DISPUTE**

- 1. Mediation of a business dispute is an alternative dispute resolution process (ADR) offered by Arizona Association of REALTORS<sup>®</sup> (AAR).
- 2. A mediation conference will be arranged when all parties agree to participate mediation is voluntary.
- 3. There is no fee associated with mediation, unlike arbitration.
- 4. A trained REALTOR® mediator will work with the parties to resolve the dispute and arrive at a mutually agreed upon settlement.
- 5. The parties to the dispute decide the settlement rather than a hearing panel decision for them.
- 6. Mediation = win-win, whereas a Hearing Panel = one winner, one loser.
- 7. If the parties to the dispute cannot agree on a settlement they may terminate the mediation.
- 8. Mediation is a confidential process.
- 9. Mediation moves faster than a formal arbitration process.

## SUBMISSION OF A REQUEST FOR MEDIATION

- 1. Have the Designated Broker [REALTOR® Principal] sign and approve request for mediation.
- 2. Include a written narrative describing the circumstances and label the narrative as Exhibit 1. Supporting documents are optional.
- 3. Once AAR receives the completed Request for Mediation AAR will contact the opposing party to offer mediation and describe the process.
- 4. If all parties agree in writing, AAR will arrange a mutually agreeable conference date.
- 5. In the event a resolution is not successful, the Complainant can file a formal arbitration request or can continue with a previously filed request.
