The state association also lobbies on your behalf by championing bills that protect private property rights, rational sign laws, utility practices and anti-deficiency laws, all of which benefit you and property owners throughout the state.

# **RISK MANAGEMENT**

The Arizona REALTORS<sup>®</sup> Risk Management department is focused on helping members Manage Risk, by developing standardized real estate forms; and **Resolve Disputes** by overseeing Professional Standards hearings.

**Forms/Advisories:** Utilizing the collective expertise of our membership and legal team, the state association has created approximately 70 standard forms to help streamline and protect everyone involved in the transaction.

Legal Hotline: The Legal Hotline delivers fast and accurate information to assist designated brokers and their designees with day-to-day legal questions that may arise. **REALTOR® Safety:** The state association established the Agent Safety Alert Program (ASAP) to alert REALTORS® of critical safety issues. **Resolve Disputes & Enforce Ethics:** REALTORS<sup>®</sup> pledge to abide by the NAR Code of Ethics. Ethics enforcement by the association is the most important distinction between a REALTOR<sup>®</sup> and a real estate licensee.

**Ombudsman Program:** Trained REALTOR® Ombudsmen help to identify and clear up any miscommunication between a party and their agent, explain customary Arizona real estate business practices and discuss available options without judgment.

**Mediation:** The state association's Mediation Program offers an opportunity for parties involved in an ethics complaint or arbitration dispute to settle the matter with the aid of a neutral third-party REALTOR<sup>®</sup> mediator.


Resolving ethics complaints and arbitration disputes through mediation is more expedient, less costly and more amicable than a hearing.

**Arbitration:** When mediation efforts are unsuccessful, or you know that mediation will not be effective in your pursuit, you may need to file a formal request for arbitration in order to resolve compensation disputes.

**Ethics Hearings:** REALTORS® are subject to discipline if found in violation of the NAR Code of Ethics.
