



## Arizona REALTORS® Key Contact Program

### *In-District Advocacy Toolkit*

#### **Overview**

As a Key Contact, you are the bridge between Arizona REALTORS® and your assigned state legislator. Your role doesn't end when the legislative session does, in fact, the months following session are some of the most valuable for relationship-building. In-district meetings provide a chance to engage your legislator one-on-one, reinforce our priorities, and build goodwill that can pay dividends in the next session.

This toolkit will help you plan, execute, and follow up on in-district meetings with your assigned lawmaker. Whether it's a coffee chat, an office meeting, or a community event, your engagement matters.

#### **Planning Your In-District Meeting**

##### *Step 1: Contact Arizona REALTORS® Government Affairs Staff*

Contact Arizona REALTORS® Government Affairs staff to let them know that you are planning to schedule an in-district meeting. Reach out to them at [lpa@aaronline.com](mailto:lpa@aaronline.com).

##### *Step 2: Reach Out Early*

Contact your assigned legislator's office to request a meeting. Use the Legislator Search in the Arizona REALTORS® Key Contact App if needed. You can reach out via phone or email—be clear, polite, and offer flexible dates.

##### *Step 3: Choose a Location*

Meetings can take place at a local office, coffee shop, or even at your brokerage or office. Hosting at your workplace can help them see firsthand what REALTORS® do for Arizona communities.

##### *Step 4: Prepare Your Message*

Arizona REALTORS® staff will provide you with a post-session summary, talking points, and any relevant issue briefs. Keep it simple—focus on 1–2 key takeaways or local impacts of REALTOR® priorities.

##### *Step 5: Make It Personal*

Speak from your experience. Lawmakers appreciate stories about how policies affect real constituents. Share your business, your community, and your passion for real estate.

##### *Step 6: Keep It Brief and Respectful*

Legislators have limited time. Plan for 20–30 minutes. Stick to your key points, offer to be a resource, and leave behind your materials.

### Key Contact Pro Tips

The following insights can help lay the groundwork for a successful meeting and help cultivate a stronger relationship with your elected official:

- **Be flexible:** Meetings may be rescheduled or moved. Roll with it!
- **Be prepared:** Know the issues and bring materials. Arizona REALTORS® staff will supply talking points.
- **Make the ask:** Be direct and confident about what you'd like your member of the Arizona Legislature to do.
- **Don't stress if you don't know something:** It's okay to follow up later. We'll help.
- **Share your story:** How does this issue affect you, your colleagues, and the real estate landscape in Arizona.
- **Follow up and report back:** Feedback helps us track progress and plan accordingly for additional legislative pushes

Keep the connection going—send a holiday card, invite them to industry events, and engage year-round.
